Many partners of Sayat Zholshy & Partners act as permanent arbitrators in the Kazakhstan International Arbitration Court.

We give particular emphasis to so-called investment and investment-related disputes which, since 2016, have been referred to the Astana City Court and Supreme Court of the Republic of Kazakhstan. As a matter of fact, currently this category covers all disputes between foreign investors and Kazakhstan government authorities, including disputes with tax and customs authorities over additional tax and other obligatory payments to the budget assessments.

- ┆ successful defence of a major oil producer operating in Mangistau Oblast, Kazakhstan, in a lawsuit connected with illegal assessment of taxes and other obligatory payments to the budget for over 65 million US dollars. The first instance judgment for satisfaction of the plaintiff's claims was upheld by higher jurisdiction courts;

One of the top priorities of the Kazakhstan-2050 Strategy is active engagement of the business community in cooperation with the government aimed at finding the best solutions to social and economic problems on the principles of a public-private partnership and implementing the “strong business, strong government” idea. Public-Private Partnership is a cooperative arrangement between the public and private sectors, typically of a mid- or long-term nature, used to finance, build and operate infrastructure and socially important projects on the principles of balanced dis-

tribution of risks, benefits, costs, rights and obligations. Sayat Zholshy & Partners keeps abreast of the times and has accumulated enormous experience in supporting the projects that use PPP mechanisms.

In the light of active promotion of a PPP approach in Kazakhstan, the number of our clients interested in this form of cooperation between the public and private sectors is steadily growing. The most popular services include legal advice, project support, legal due diligence, etc.
